Sub: Enforcement Proceedings against Senda International Capital Limited – SICC finalised timelines and hearing of an alternative relief application. Updates on Court case in Singapore in Compliance with Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

We are pleased to inform that the Singapore International Commercial Court (SICC) at Case Management Conference held on 24 August, 2023, has finalised below timelines on the alternative relief application filed for the enforcement of final valuation amount of US\$603.80 million of our stake in DyStar as decided by SICC.

- a. 2 October 2023: Defendants (DyStar/Senda) to file reply affidavit and expert report.
- b. 13 November 2023: Plaintiff (Kiri) to file further reply affidavit and reply expert report (if any).
- c. 4 December 2023: Defendants (DyStar/Senda) to file a final reply expert report (if any).
- d. 8 December 2023: Parties to write in jointly whether expert is desirable for the hearing.
- e. 12 January 2024: Parties to file and exchange written submissions.
- f. 24-26 January 2024: Hearing
