## PROCEEDINGS OF EXTRA ORDINARY GENERAL MEETING HELD ON JULY 31, 2024

The Extra Ordinary General Meeting (EGM) of the Company was held on Wednesday, July 31, 2024 at 11.00 a.m. through Video Conference ("VC"). The meeting was held in compliance with the Circular Nos. 14/2020, 17/2020, 20/2020, 02/2021, 21/2021, 02/2022, 10/2022 and 09/2023 issued by the Ministry of Corporate Affairs ("MCA") and Circular No. SEBI/HO/CFD/CMD1/CIR/P/2020/79, SEBI/HO/CFD/CMD2/CIR/P/2021/11, SEBI/HO/CFD/CMD2/CIR/P/2022/62, SEBI/HO/CFD/PoD-2/P/CIR/2023/4 SEBI/HO/CFD/CFD-PoD-2/P/CIR/2023/167 issued by the Securities and Exchange Board of India ("SEBI") (collectively referred to as "the Circulars") and as per other applicable provisions of the Companies Act, 2013 and the Rules made thereunder.
