## PROCEEDINGS OF 27th ANNUAL GENERAL MEETING HELD ON SEPTEMBER 29, 2025

The meeting was held in accordance with General Circular No. 20/2020 dated May 05, 2020, as amended from time to time and most recently amended by Circular No. 09/2024 dated September 19, 2024, issued by the Ministry of Corporate Affairs ("MCA"), read with SEBI Circular No. SEBI/HO/CFD/CFD-PoD-2/P/CIR/2024/133 dated October 03, 2024, issued by the Securities and Exchange Board of India ("SEBI") (collectively, the "Circulars") and as per other applicable provisions of the Companies Act, 2013 and the Rules made thereunder.
